Located in beautiful Solvang, the courses par 72 design was completed in late 1992. Halsey- Daray Architects made full use of the natural rolling terrain to develop lush fairways and challenging greens.

The River Course, located on the famous 10,000-acre Alisal Ranch, is surrounded by the Santa Ynez Mountains, oak trees, native sycamores, elderberry trees, four lakes, and the Santa Ynez River, making this course any golfers delight.
